WHO MAY APPLY: This is a Maryland Army National Guard position open to Traditional Officers, Technician Officers with the rank of CPT or 1LT (promotion eligible), and those Officers eligible for membership in the MDARNG.

DESCRIPTION OF DUTIES: Commander for Company B (I&S), HHB, 29th Infantry Division. Establish and effectively communicate a vision necessary to execute training and mobilization plans for forces that are ready, relevant, and capable of performing full spectrum military operations on either federal or state missions. Develop leadership, technical, and tactical skills of the Platoon Leaders and other staff officers and warrant officers. Sustain company readiness by exercising strength management, soldier retention, equipment maintenance, military specialty and weapons proficiency, as well as, ensuring medical well-being and physical training. Provide the necessary support to the battalion and division. Conduct a family readiness program that prepares Soldiers and their families for deployment while recognizing their contributions and sacrifices. Perform other duties as assigned.

REQUIRED QUALIFICATIONS: Applicant must be an officer in the rank of CPT or 1LT (promotion eligible) and must (at a minimum) be currently enrolled in military/civilian education commensurate with rank, policy and regulation. Requires ability to receive a Top Secret/SCI clearance .

SPECIAL INFORMATION

Position is not gender restricted. Assignment limitations of NGR 600-100 apply. Application for this position DOES NOT constitute application for entry into the fulltime federal technician or Active Guard Reserve (AGR) programs.

1. Memorandum requesting consideration from officer applying with reason why the officer wants to be the Company Commander.
2. Current ORB/ERB
3. OERs for the past five years (Must be electronically profiled or certified true copy; gaps, overlaps, or non-rated periods must be explained in Memorandum format).
4. Most recent DA 1059 indicating highest military education completed
5. DA Form 705 (APFT Scorecard) within 12 months of the closing date. A physical profile may be submitted in lieu of APFT record.
6. Height-Weight Statements within 6 months of the closing date. DA Form 5500-R/5501-R must be included if soldier exceeds authorized screening table weight of AR 600-9.
7. DA Photo within five years; photo must reflect current rank, awards/ribbons.
8. MEDPROS printout individual PQR indicating Periodic Health Assessment is current.
9. Letter of recommendation from chain of command. (Optional)

All applications will be screened without regard to ethnicity, religion, gender, sexual orientation, or national origin. Selection will be made the basis of military education, skills and individual experience.
