WHO MAY APPLY: Open to all Traditional M-Day Infantry or Armor Officers in the rank of CPT or 1LT immediately eligible for promotion of the Maryland Army National Guard only.

DESCRIPTION OF DUTIES: Commands a worldwide-deployable IBCT Infantry Heavy Weapons Company consisting of approximately 90 Soldiers. Responsible for everything the company does or fails to do, including combat power generation. Exercises mission command over four platoons and administratively responsible for staff sections through presence, fully communicated guidance and intent, leadership by example, and leveraging staff competencies. Allows subordinate leaders to exercise initiative to the maximum extent possible. During TR1 and TR2 phases during the rated period, ensures teams throughout the organization are trained, crew, section, and platoon level proficiency is attained at critical battle tasks, and platoons and sections continue to improve on approved METL collective tasks using doctrinal Training and Evaluation Outlines.

REQUIRED QUALIFICATIONS: Graduation of Basic Officer Leaders Course required. Graduate of Company Level Leader's Course and Maneuver CCC preferred. Must be qualified in 11A, 19A, 19B, or 19C MOS. Must hold a Secret clearance. Must meet the physical requirements of AR 350-15, AR 600-9 and AR 40-501. Applicant must not be currently under suspension of favorable personnel actions.

SPECIAL INFORMATION

Position is gender restricted to male officers only. Assignment limitations of NGR 600-100 apply. Application for this position DOES NOT constitute application for entry into the fulltime federal technician or Active Guard Reserve (AGR) programs.

5. DA Form 705 (APFT Scorecard) within 12 months of the board date. A physical profile may be submitted in lieu of APFT record.
6. Height-Weight Statements within 6 months of the board date. DA Form 5500-R/5501-R must be included if soldier exceeds authorized screening table weight of AR 600-9.
7. Optional applicant memorandum to provide additional information to the president of the selection board not contained in the above listed documents.

All applications will be screened without regard to ethnicity, religion, gender or national origin. Selection will be made the basis of military education, skills and individual experience.
