WHO MAY APPLY: Open to all traditional (M-Day) officers of the Maryland Army National Guard in the rank of CPT (O3) and 1LT immediately promotable to CPT.

DESCRIPTION OF DUTIES: Commands a Military Police Company, providing command guidance and direction for 167 Soldiers in training, administration, logistics, and retention. Ensures the unit maintains a high level of readiness in order to mobilize and deploy for assigned state and federal Missions. Maintains property accountability and ensures all arms and equipment are fully mission capable. Mentors and develops junior officers and noncommissioned officers for current and future leadership positions. Leads the company in accomplishing the goals and objectives established by the battalion and higher headquarters.

REQUIRED QUALIFICATIONS: Must be a CPT (O3) or 1LT (O2) immediately promotable, and should, at a minimum, be a graduate of the Military Police Officer Basic Course, and preferably an MP CPT Career Course graduate. Officers who are not MP qualified may apply; however, if selected, must become MP qualified within 18 months of assignment. 1LTs who are not MP qualified cannot be promoted to CPT in this position to until they become MP qualified. Must possess a current security clearance of Secret or higher. Must be of high moral character and meet the physical requirements of AR 350-15, AR 600-9 and AR 40-501. Applicant cannot be currently under suspension of favorable personnel actions.

This position is not gender restricted. Assigned limitations of NGR 600-100 apply.

3. Officer Record Brief (ORB)
4. Personnel Qualifications Record (PQR).
5. DA Form 705 (APFT Scorecard) within 12 months of the board date. A physical profile may be submitted in lieu of APFT record.
6. Height-Weight Statements (mandatory for applicants) within six months of the board date. Include the DA Form 5500-R/5501-R if the officer exceeds the authorized screening table weight of AR 600-9.

All applications will be screened without regard to ethnicity, religion, gender or national origin. Selection will be made the basis of military education, skills and individual experience.
