WHO MAY APPLY: Open to traditional (Mday) Transportation (88A), Ordnance (91A), Quartermaster (92A) and Logistics (90A) officers or those eligible for branch transfer of the Maryland Army National Guard only in the ranks of CPT or 1LT eligible for immediate promotion upon selection.

DESCRIPTION OF DUTIES: Commands the 1229th Transportation Company (Light Medium Truck Company) with an authorized strength of 160 Soldiers. Responsible for planning and executing individual training of Soldiers and collective training of the company towards full mission readiness in support of combat and state emergency missions. Responsible for accountability and maintaining property valued over \$12 million. Responsible for the overall health, welfare, training and professional development of the Soldiers assigned to the Company.

REQUIRED QUALIFICATIONS: Graduate of Basic Officer Leaders Course required. Graduate of the Company Level Pre-Command Course and the LG Captain's Career Course strongly preferred. If the officer selected is not 90A qualified, they have to become 90A qualified within 18 months. Must hold a secret clearance. Must meet the physical requirements of AR 350-15, AR 600-9 and AR 40-501. Applicant must not be currently under suspension of favorable personnel actions.
